Selected candidates will be liable to serve anywhere in India or abroad. On appointment, the candidates shall be governed by the ITBPF Act, 1992 and ITBPF Rules, 1994 and other Rules applicable from time to time. Applications from candidates will be accepted through ONLINE MODE only. No other mode for submission of application is allowed. ONLINE APPLICATION MODE WILL BE OPENED W.E.F. 2ND SEPTEMBER, 2024(02/09/2024) AT 00:01 AM AND WILL BE CLOSED ON 1ST OCTOBER, 2024 (01/10/2024) AT 11:59 PM. The applicants are advised to check their eligibility before applying so as to avoid disappointment at a later stage.

- (1) The vacancies are tentative and may increase or decrease without any notice. Any change in the number of vacancies will be intimated through ITBPF Recruitment website i.e. https://recruitment.itbpolice.nic.in.

- iii) Candidates claiming Economically Weaker Sections (EWS) status may note that their certificate of Income & Assets should be based on the financial year prior to the year of application and should be in possession before the closing date for submission of online applications, i.e. 1st October, 2024 (01/10/2024).
- iv) Candidates claiming **OBC** (**NCL**) status may note that certificate on non-creamy layer status should be based on the income earned during three previous financial years (i.e. 2023-24, 2022-23 and 2021-22) and should be in possession before the closing date of submission of online applications, i.e. 1st October, 2024 (01/10/2024).

- (i) A colour blind person will not be eligible for appointment. If at any stage of service career, a person is found to be colour blind, he will be medically boarded out as per SHAPE policy in vogue in the ITBPF.
- (ii) The candidates must not have knock knee, flat foot, varicose vein or squint in eyes and should possess colour perception CP.III and must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of the duties.

(b) Tattoos: -

- (a) <u>Content</u>: Being a secular country, the religious sentiments of our countrymen are to be respected and thus, tattoos depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.
- (b) Location: Tattoos marked on traditional sites of the body like inner aspect of forearm but only left forearm, being non saluting limb or dorsum of the hands are to be allowed.
- (c) <u>Size</u>: Size must be less than ¼ of the particular part (Elbow or Hand) of the body.

Note :-

In case, a candidate has undergone removal of tattoo (s) prior to appearing for recruitment process and the same has faded substantially, this will be treated as a "scar" and not a tattoo. Such candidates will be permitted to undergo the entire selection process with the approval of Presiding Officer of the recruitment Board. Further, the scar resulting due to removal of tattoo will be reviewed by the Medical Board of Officer during Detailed Medical Examination (DMF).

5. HOW TO APPLY AND BY WHICH DATE:-

a) Eligible and interested candidates need to apply online through ITBPF website https://recruitment.itbpolice.nic.in. Candidates are advised to fill the application form after reading the instructions carefully and should provide genuine and functional e-mail ID and Mobile number at the time of filling online application form. Details as required under various segments should be mentioned clearly, correctly and logically. As the applications need to submit online only, application received offline shall not be considered and will be rejected summarily.

b) Candidates are to fill all information e.g. Gender/Category (UR/SC/ST/OBC (NCL)/EWS etc), Employment status/Riots affected, etc. in the profile created on ITBP recruitment website before submission of online application. Any false/incorrect information in online application will lead to cancellation of candidature and no request for change in such details will be considered at later stages.

c) APPLICATION FEE & MODE OF PAYMENT — Male candidates belonging to General (UR), OBC and EWS category applying for this recruitment will have to pay Rs. 100/- (Rupees one hundred only) as application fee through online payment gateway system on https://recruitment.itbpolice.nic.in. Application received with any other mode of fee payment will be summarily rejected. Candidates belonging to Scheduled Caste, Scheduled Tribe, Females and Ex-servicemen are exempted from paying the fee.

Note:-

- i) Fee once paid will not be refunded under any circumstances.
- ii) Fee paid by modes other than online mode will not be accepted and the applications of such candidate will be rejected forthright. Besides above, the payment made in such cases shall stand forfeited.
- d) Candidates working in Central/State Government/ Autonomous/ Statutory Bodies/ Public Sector Undertaking etc. applied to the post are required to furnish "No Objection Certificate" in original as per Annexure-VI issued by the employer at the time of verification of documents. The candidature of candidates who fail to submit "No Objection Certificate" at the time of documentation shall be summarily rejected.

6. SELECTION PROCESS:-

- a) Admit Cards to the candidates will be issued online mentioning the date and venue of recruitment test. Candidature of candidates who are issued online admit cards will remain provisional till they are finally selected and submit all related documents/certificates in original and in prescribed format at the stage of verification of original documents.
- b) Candidates are required to bring a clear & legible print out of their online application form & admit card; else they will not be permitted to enter the venue of Physical Efficiency Test (PET) & Physical Standard Test (PST).

Note:-

- (i) Before start of PET & PST, the candidates will undergo thorough verification of identity including Biometric capture.
- (ii) Biometric identification of candidates can also be verified at any stage of recruitment.
- (iii) It is candidate's responsibility to check before hand that the biometric machines are able to capture the fingerprint image. In case, if the biometric machine is not able to capture the fingerprint image due to Mehndi, wax, etc. then, the candidate will not be allowed to appear in the examination.
- (iv) Failure in biometric verification at any stage will lead to cancellation of candidature.

- (ii) No marks will be awarded for this test and PET shall be qualifying in nature. Candidates have to qualify each event of PET, those who do not qualify shall be eliminated.
- (iii) On reporting of female candidates for Physical Efficiency Test (PET) & Physical Standard Test (PST), a self declaration indicating about her pregnancy status shall be submitted. In case, if she declares that she is not pregnant then, she may be allowed to participate in the PET/PST. In case of false declaration, all the risk for undergoing PET/PST will be of her own.
- (iv) If, the female candidate declares that she is pregnant before PET/PST, then a confirmatory pregnancy test to be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she may be declared temporary unfit and her appointment shall be held in abeyance until the confinement is over. However, female candidate who are declared temporary unfit will require to appear and qualify in remaining stages of recruitment i.e. PST, Written Examination, Documentation and Medical Examination. The vacancy against which a women candidate was selected will be kept reserved for her. She will be re-examined for PET/PST six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit, she may be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. In case, a female candidate is found negative for pregnancy, she may be allowed to participate in the PET/PST. However, it shall be mandatory for temporary unfit female candidate to appear and qualify PST. Written Examination, Documentation and DME/RME and has to secure place in final selection list of respective category.

<u>Note</u>: PET will not be held for Ex-servicemen. However, they require to qualify the requisite PST, Written Examination, Documentation and Medical Examination.

PHYSICAL STANDARD TEST (PST) (i) Candidates who qualify in PET will be screened for Height, Weight and Chest measurement (Chest measurement for male candidates only). Those who do not meet the required physical measurements, as applicable will be eliminated at that stage and rejection slip shall be issued by the Presiding Officer.



- (ii) Physical Standard of female candidates shall be measured by female staff only. Chest measurement of female candidates should not be taken. Besides, in case of female pregnant candidates shall be dealt as per instructions issued by the Central Government for PET/PST stage.
- (iii) Candidates who fail to qualify PST shall be eliminated from that stage and rejection slip shall be issued by the Presiding Officer.
- (iv) Rejection slip for less in height and chest will be issued at the time of PST. Board shall ensure that measurement is mentioned in writing in the rejection slip. In case, if candidate is not satisfied with the physical measurement recorded by the Board, he/she may make a representation/appeal in writing to the Presiding Officer of the Recruitment Board on the same day for re-measurement. In such case, the physical measurement of aggrieved candidate(s) shall be measured by the Presiding Officer himself and shall dispose off the representation/appeal immediately in writing to the candidate then and there. In case any candidate refuse to sign or leave the PST centre without signing the rejection slip, the recruitment board should endorse the remarks in the rejection slip as "candidate refused to sign/candidate left without receiving rejection slip/candidate did not turn up to receive rejection slip" and same may be kept in record properly after duly signed by the Presiding Officer of the board.
- (v) Underweight/overweight candidates will be allowed to participate for next stage of recruitment and shall not be debarred at PST stage. The final decision on fitness/unfitness due to underweight/overweight will be decided at the time of Detailed Medical Examination (DME) based on the weight and age on the day of DME and the height as measured by the PST Board.
- (vi) The decision of the Presiding Officer will be final and no further appeal or representation in this regard will be entertained thereafter. There is no provision of appeal for Physical Efficiency Test (PET).

<u>Note</u>: PET will not be held for Ex-servicemen. However, Exservicemen will be required to qualify the requisite PST, Written Examination, Documentation and Medical Examination.



iii) The minimum cut-off percentage of marks for qualifying in written examination will be as follows:-

- iv) Answer Key of the question paper will be uploaded on ITBPF recruitment website i.e. https://recruitment.itbpolice.nic.in after the written examination is completed.
- v) Candidates are not permitted to use mobile phone, calculators or any other electronic/electrical devise. Possession of these items, whether in use or not, will be considered as "use of unfair means" in the examination and appropriate action will be taken against such candidates.



- vi) Candidates found copying or using any unfair means should be disqualified and debarred from further test. An endorsement also be made in all such confiscated answer sheets by the Board/Observer to this effect.
- vii) No representation for revaluation of answer sheet of written examination or re-conduct of written examination will be entertained.


PHASE - III

MERIT LIST

- (i) After completion of Written Examination, Merit list in each category namely UR, SC, ST, OBC (NCL), EWS and Exservicemen will be drawn on the basis of marks obtained by the candidates in the written examination. On the basis of merit, the candidates shall be shortlisted for verification of original documents (Documentation) and Detailed Medical Examination (DME) as per the category-wise vacancies. The number of candidates examined will be equal to the number of vacancies increased by average failure rate of Detailed Medical Examination (DME) and Review Medical Examination (RME) determined on the basis of past experience. However, there shall be no reserve list.
- (ii) SC, ST, OBC (NCL) & EWS candidates who are selected on their own merit without relaxed standards will not be adjusted against the reserved share of vacancies. Such SC, ST, OBC (NCL) & EWS candidates shall be accommodated against the General vacancies as per their position in overall merit list. The reserved vacancies will be filled up separately from amongst eligible SC, ST, OBC (NCL) & EWS candidates which will thus, comprise of SC, ST, OBC (NCL) & EWS candidates who are lower in merit than the last General candidate on merit list of unreserved category but otherwise found suitable for appointment even by relaxed standard.
- (iii) In case of recruitment to the vacancy reserved for Exservicemen and those remained unfilled due to non-availability of eligible or qualified Ex-servicemen candidates, the same shall be filled up from the Non Ex-servicemen candidates as per merit list of respective categories.

(iv) Resolution of Tie Cases:

- (i) In case of tie in marks, the candidate with older age will be higher in merit.
- (ii) If the tie still persists, the candidate whose names come first in the alphabet order (English) will be kept higher in the merit.



The candidates will be shortlisted in order of merit in each category will be put through verification of original documents. Testimonials of the candidates will be checked before Detailed Medical Examination (DME). Original documents will be returned on the spot after verification and self attested copies of certificates will be retained with the application. Original copies of following documents will be required for verification:

- (i) Educational Certificate(s) alongwith Course certificate(s), as required.
- (ii) Date of birth Certificate (Matriculation or 10th Class Certificate).
- (iii) Professional/Experience Certificate, if any.
- (iv) Scheduled Caste (SC) and Scheduled Tribes (ST) Certificate as per Annexure-'I', OBC certificate as per Annexure-'II' and Economically Weaker Sections (EWSs) Certificate (valid for the year 2023-2024) as per Annexure-'III' (if belonging to any of these categories) issued by an authority not lower than Tehsildar or SDO. Certificates obtained in any other format will not be accepted. Candidates claiming OBC status may note that certificate on non creamy layer status as per Annexure-'II-A' should have been obtained within three years before the closing date i.e. 1ST October, 2024 (01/10/2024).
- (v) Certificate as per Annexure-'V' for claiming relaxation in height & chest (if applicable).
- (vi) Persons serving in Government Services applying for the post are required to furnish "No Objection Certificate" in original as per Annexure-'VI' issued by their employer at the time of physical verification of documents. Candidates who fail to submit N.O.C. at the time of documentation shall be summarily rejected.
- (vii) Domicile Certificate issued by Local Revenue Authorities or PAN Card or Aadhar Card or Driving License or Voter Card etc. for verification of citizenship. In case of West Pakistani Refugees settled in Jammu and Kashmir (UT), they are required to produce Certificate in the format attached as Annexure-'IV' issued by the Sarpanch/Numberdar of the candidate's village to the effect that the person belonged to the West Pakistani Refugees Category, along with a copy of Electoral Roll showing the

The Detailed Medical Examination of the candidates will be conducted in terms of Uniform Guidelines for Recruitment Medical Examination for GOs and NGOs in CAPFs and AR issued vide MHA U.O.
